## A REQUIRED DOCUMENTS CHECKLIST FOR YOU

Take the following documents with you when applying for a driver license or temporary instruction permit at any Department of Revenue contract license office:

- 1) Identity- Documents used to verify identity must contain your full legal name and date of birth. Many lawful status documents also prove identity. Other examples include:
  - U.S. Birth Certificate
  - Employment Authorization Document
  - Missouri or Out-Of-State License
  - Foreign Passport with U.S. Visa Accompanied by an I-94.
- 2) Lawful Status- Provide documents to verify U.S. citizenship or lawful immigration status. Examples include, but are not limited to:
  - U.S. Birth Certificate (hospital birth certificates are not acceptable)
  - U.S. Passport or Passport Card
  - I-551 Permanent Resident Card
  - I-327 Re-entry Permit.
- 3) Social Security Number
  - Social Security Card
  - W-2 Form
  - 1099 Form
  - Payroll Stub
  - Letter from the Social Security Administration (SSA) regarding the status of your Social Security Number eligibility if a number has not been assigned.
- 4) Name Change - Present one of the documents below to verify name change:
  - Certified Marriage Certificate;
  - Certified Divorce Decree;
  - Certified Court Order;
  - Certified Court Order - Adoption.
- 5) Missouri Residency - For a REAL ID-compliant transaction, you must provide two documents verifying residential address. For a non-REAL ID compliant transaction, you must provide one document verifying residential address. If you have a separate mailing address, you must provide a document to verify the mailing address. Examples include, but are not limited to:
  - Driver License or Motor Vehicle Renewal Postcard
  - Voter Registration Card
  - Utility Bill
  - Property Tax Receipt
  - Mortgage, Housing, or Leasing Document
