Information Regarding Use of Driveaway License Plates and Permits	 Driveaway license plates and permits shall only be used by owners, corporate officers, or employees of the business to which the plate or permit was issued. Trailer dealers may purchase one driveaway license plate to demonstrate a motor vehicle acquired by the dealer as a trade-in, if applicable (see Section 301.550, RSMo). Driveaway operations are defined as follows: The movement of a motor vehicle or trailer by any person or motor carrier other than a dealer over any public highway, under its own power singly, or in a fixed combination of two or more vehicles, for the purpose of delivery for sale or for delivery either before or after sale; The movement of any vehicle or vehicles, not owned by the transporter, constituting the commodity being transported, by a person engaged in the business of furnishing drivers and operators for the purpose of transporting vehicles in transit from one place to another by the driveaway or towaway methods; or The movement of a motor vehicle by any person who is lawfully engaged in the business of transporting vehicles that are not the person's own and vehicles of a type otherwise required to be registered, by the driveaway or towaway methods, from a point of manufacture, assembly or distribution or from the owner of the vehicles to a dealer or sales agent of a manufacturer or to any consignee designated by the shipper or consignor.
Photo and Issuance	You must include proof of financial responsibility sufficient to cover each motor vehicle which will be operated with driveaway plates or permit. You must include a photograph of your business building and business sign (photographs must not exceed 8x10 inches and no smaller than 5x7 inches). The business phone number provided with the business address must be a land line. The business phone number cannot be a cell phone.
