

## IT'S TIME TO RENEW YOUR DRIVER LICENSE, NONDRIVER LICENSE OR PERMIT!

Effective October 1, 2021, you will need to present a REAL ID driver license, nondriver license or permit (or other acceptable identification document, i.e., passport) to board domestic flights and access certain federal facilities, including military bases and nuclear power plants.

You now have two options when it comes to renewing your driver license, nondriver license or permit. Valid, original documents demonstrating proof of each item listed in Option 1 or Option 2 must be provided when applying for your preferred card type.

### OPTION 1: CURRENT CARD/DOCUMENT - NOT FOR REAL ID PURPOSES

Simply renew your current driver license, nondriver license or permit. Current driver licenses, nondriver licenses, and permits will continue to be acceptable for driving and identification purposes, other than for REAL ID purposes.

#### VERIFICATION OF:

#### COMMONLY USED DOCUMENTS:

<b>Identity</b> (full legal name and date of birth)	Current Driver License Current Nondriver License Current Permit
<b>Social Security Number</b>	Social Security Card (signed) or verbally provide number
<b>Missouri Residency</b>	Driver License Renewal Postcard, Utility Bill, or Pay Check <b><i>Class A, B or C license holders must present at least TWO separate documents. Class E, F, or Nondriver license applicants must provide at least ONE document.</i></b>
<b>Name Change</b> (if applicable)	Certified Marriage License or Certified Court Order <b><i>If your current name is different than the name on your identity and lawful status document a name change document to tie current and former name(s) is required.</i></b>

### OPTION 2: REAL ID CARD/DOCUMENT

All documents presented for a REAL ID driver license, nondriver license or permit will be imaged and retained for a minimum of ten years.

#### COMMONLY USED DOCUMENTS:

<b>Identity</b> (full legal name and date of birth)	<b>Lawful Status (U.S.)</b> U.S. Birth Certificate (original, certified) or U.S. Passport (unexpired)
<b>Social Security Number</b>	Social Security Card (signed), W-2, Form 1099, or payroll stub ( <b><u>Cannot</u> verbally provide</b> )
<b>Missouri Residency</b>	Driver License Renewal Postcard, Utility Bill, or Pay Check <b><i>Must provide at least TWO separate documents with address.</i></b>
<b>Name Change</b> (if applicable)	Certified Marriage License or Certified Court Order <b><i>If your current name is different than the name on your identity and lawful status document a name change document to tie current and former name(s) is required.</i></b>
