

## It's time to renew your driver license, nondriver license or permit!

Effective October 1, 2020, you will need to present a REAL ID driver license, nondriver license or permit (or other acceptable identification document, i.e., passport) to board domestic flights and access certain federal facilities, including military bases and nuclear power plants. You now have two options when it comes to renewing your driver license, nondriver license or permit. **Valid, original documents demonstrating proof of each item below must be provided when applying for your preferred card type:**

Simply renew your current driver license, nondriver license or permit. Current driver licenses, nondriver licenses, and permits will continue to be acceptable for driving and identification purposes, other than for REAL ID purposes.		Request a REAL ID compliant driver license, nondriver license or permit. (A commercial driver license permit cannot be REAL ID compliant.) Beginning March 25, 2019, you will have the option to apply for a REAL ID compliant document.
