The Department offers alternative filing methods:

- TXP Bank Project is offered for withholding tax, declaration of estimated corporation income tax payments, and sales and use tax payments.
- Online filing and payments are offered for individual income tax, sales tax, use tax, tire and battery fee, and withholding tax. Online payments are offered for corporation income tax, motor fuel tax, and tobacco tax on the Department's website at <http://dor.mo.gov/business/payonline.php>.

NOTE: An alternative payment method must be used for quarter-monthly sales and withholding tax payments. Paper vouchers are not offered. Visit the Department's website at <http://dor.mo.gov/electronic/>, telephone (573) 751-3505, or e-mail [elecfile@dor.mo.gov](mailto:elecfile@dor.mo.gov) to learn more about alternative filing methods.

The Department also encourages electronic or internet filing options for individual income tax. In 2018, the Department received more than 2,600,000 electronically filed returns. Electronically filed returns offer many benefits to the taxpayer including receipt acknowledgment, faster refunds, accuracy, and convenience.
