

## Sales Tax Exemption Statement For Public Utility Company

Effective August 28, 2024, pursuant to [144.058, RSMo.](#), Missouri Sales Tax will not be assessed on motor vehicles, trailers, boats, or motors owned by public utility companies, and used to facilitate the generation, transmission, distribution, sale, or furnishing of electricity. This form must be completed prior to application for title if the company is not listed on the Public Service Commission website at [psc.mo.gov/UtilityLocator.aspx](#). All applications must be in the public utility company's business name to qualify for exemption.

## Instructions

The public utility companies who generate, transmit, distribute, sell, or furnish electricity, but are not listed by the Public Service Commission, may apply for an exemption from sales tax by submitting the following:

1. Complete the exemption form Sales Tax Exemption Statement For Public Utility Company (Form 5995);
2. A signed Application for Missouri Title and License ([Form 108](#));
3. The [Certificate of Title](#), properly signed over to you or [Manufacturer's Statement of Origin \(MSO\)](#);
4. A notarized Lien Release ([Form 4809](#)), if applicable;
5. Pay title fee of \$8.50; and
6. Pay processing fee of \$9.00.
