#### Instructions

- 1. List the total sales made in cities where a license fee or occupation tax was charged. The details of these sales must be listed on Schedule 1. Indicate each city's total on a separate line and attach additional pages if necessary.
- 2. Provide the total sales made in Jackson County for cities listed on Schedule F.
- 3. Provide the total sales made in Jackson County excluding the sales in cities listed on Schedule F.
- 4. Provide the total sales made in Jackson County. (Section E = Totals of (A) + (C); Section F = Totals of (B) + (D))
- 5. Provide the total sales made in St. Louis County.
- 6. Provide the total sales for all other sales made in Missouri. The details of these sales must be listed on Schedule 2.
- 7. Compute the total sales of the first page.
- 8. Compute the total sales from all additional pages.
- 9. Compute the grand total of sales.
