# **ANNUAL BUDGET FOR FY 2023**

This Annual Budget for the 2023 fiscal year of the Green Trails Community Improvement District (the "CID" or "District") constitutes the proposed annual budget of the CID pursuant to Section 67.1471.2, RSMo. The Missouri Community Improvement District Act (the "CID Act") requires the CID to adopt an annual budget setting forth expected expenditures and revenues from taxes of the CID. The fiscal year of the CID is the same as the fiscal year of St. Louis County, MO, which runs from January 1 to December 31 of each year. This budget sets forth **expected** revenues and expenditures of the CID as contemplated by its Board of Directors for the fiscal year beginning January 1, 2023 through December 31, 2023. Actual revenues and expenditures may vary due to a variety of factors that are unknown at this time, including, the costs of administration of the CID and the amount of taxable retail sales within the CID. The CID was formed in May 2017 and began to generate revenue in 2018. This budget is not intended to and does not limit the CID or its Board of Directors in any way in the event that the actual revenues or expenditures vary from those stated herein.

#### 1. Expected Revenues

The revenues expected by the CID in FY 2023 are estimates based on the amount of taxable retail sales within the District in FY 2023. Based on past performances of the retailers within the CID, it is estimated that the one percent (1%) CID sales tax will generate approximately \$35,000. Please note that this amount has been reduced due to the loss of certain retailers previously located in the District and the associated negative impact on taxable sales. However, the estimated revenue amount is only a projection based on potential taxable retail sales within the CID and is subject to change.

#### 2. Expected Expenditures

All revenue of the CID is specifically dedicated to the following: 1) reimbursement for CID project costs, including, but not limited to the following:

- Construction and maintenance of parking lots, structured parking garages and other parking facilities;
- Construction and maintenance of parks, lawns and other landscaping;
- Construction and maintenance of streetscaping, lighting and outdoor plazas;
- Construction of sidewalks, streets, utilities, drainage, water, storm and sewer systems and other site improvements;
- The renovation and rehabilitation of buildings and structures;
- Operating parking facilities, bus and other modes of transportation;
- Providing security for the protection of persons and property;
- the acquisition of interests in real property to the extent necessary to carry out the such improvements; and
- the provision of managerial, engineering, legal, technical, clerical, accounting or other assistance in connection with the improvements.

# 3. Rates of Assessment

The CID has not imposed any special assessments upon real property within the District.

# 4. Rates of Taxes

Pursuant to Resolution No. 2017-03 of the CID, which resolution was subsequently approved by the qualified voters of the District, the CID has imposed a sales tax upon all taxable retail sales within the District in the amount of one percent (1%). The CID sales tax became effective as of 10/1/2017. The CID has not imposed any real property tax or special assessments.

# A RESOLUTION OF THE BOARD OF DIRECTORS OF THE GREEN TRAILS COMMUNITY IMPROVEMENT DISTRICT APPROVING THE EXPENDITURES OF DISTRICT REVENUNES

WHEREAS, the Green Trails Community Improvement District (the "District") is a Missouri Community Improvement District and political subdivision of the State of Missouri that was formed pursuant to sections 67.1401 to 67.1571, RSMo, (the "CID Act") and Ordinance No. 26,750 (2017) of St. Louis County, Missouri (the "Ordinance"); and

WHEREAS, the CID Act authorizes the District to expend its revenues on improvements and services benefitting the properties within the District; and

WHEREAS, during the period beginning January 1, 2022 through December 31, 2022, the District may be requested to pay for improvements and services related to the District's Projects as detailed pursuant to the Amended Development Agreement authorized by the District's Resolution No. 2018-04; and

WHEREAS, the Board of Directors of the District does by this resolution authorize a process for review and approval of all expenditures to be made pursuant to the Amended Development Agreement for the period beginning January 1, 2022 through December 31, 2022.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE GREEN TRAILS COMMUNITY IMPROVEMENT DISTRICT, AS FOLLOWS:

#### SECTION NO. 1

As set forth in the Amended Development Agreement, all costs of any improvements or services necessary or incidental to the District's Project, shall constitute the "Project Costs." The Developer(s) under the Amended Development Agreement will provide a certificate (the "Cost Certificate") to the CID, in such form as is reasonably acceptable to the CID, with reasonable documentation attached, evidencing that Developer(s) has incurred Project Costs.

Upon the delivery of a Cost Certificate to the CID, the CID, through its officers and Executive Director, will seek review of such Cost Certificate by independent CID legal counsel to confirm that the District can legally pay such Project Costs under the CID Act. After approval of both the District's officers and CID legal counsel that the Project Costs are in accordance with the requirements of the CID Act, RSMo, the District's By-Laws and any other internal procedures of the District, the Project Costs will be paid from available CID revenues.

**SECTION NO. 2** 

In accordance with Section No. 1 above, the Board of Directors has been presented a Cost Certificate prepared by Developer requesting reimbursement for Project Costs associated with security services provided within the boundaries of the District. This Cost Certificate has been reviewed and approved by both the Executive Director and legal counsel to the District. Based on the Board of Directors' review of this Cost Certificate, the Executive Director of the District is directed to make such reimbursement from the Project Funds of the District.

# Re: Reimbursement to Maritz for CID-Eligible Security Expenses by Green Trails Community Improvement District

Dear Mark:

As background, the Green Trails Community Improvement District (the "CID") and Maritz have entered into an Amended Development Agreement ("Agreement") providing that Maritz will cause the construction and maintenance of certain improvements and/or the provision of certain services that constitute the CID Projects. As part of this Agreement, the CID has an obligation to reimburse Maritz for costs associated with such CID Projects. In order to document such costs, Maritz is required by the Agreement to deliver a Cost Certificate to the CID with documentation evidencing and attesting that Maritz has incurred the described Project Costs. Maritz has prepared Cost Certificate Number 2022-01 dated 11/10/2022 requesting reimbursement of certain costs from the CID (a copy of this Cost Certificate is attached for reference). As district counsel for the Green Trails Community Improvement District (the "CID"), we have been asked review Cost Certificate Number 2022-01 and determine if the requested reimbursements are consistent with the requirements of the Missouri Community Improvement District Act ("CID Act"), which is set forth in §§ 67.1401 – 67.1571, RSMo.

Cost Certificate Number 2022-01 shows Maritz is seeking reimbursement for its payment of the following:

We have examined the invoices issued by Securitas Security Services USA, Inc. that were attached by Maritz to Cost Certificate 2022-01. The payment by the CID related to Maritz Cost Certificate 2022-01 is proper under the CID Act. Based on our review of the request and applicable statutory law, the CID is authorized to expend its funds on Mr. Mark Winkeler Green Trails CID November 14, 2022

The 2022 annual meeting of the board of directors (hereinafter "the board") of The Green Trails Community Improvement District (hereinafter "the District") was held on Wednesday, November 16, 2022, commencing at 10:30 a.m. at the District's offices at 1375 North Highway Dr., Fenton, MO 63099 pursuant to notice duly given to the directors, the public and other interested parties.

The following directors of the District were present: Steve Maritz, Rick Ramos (participating via teleconference), Chris Carril and Mark Winkeler. Also present was Scott Riley of Cook & Riley, LLC. Scott Riley called the meeting to order and recognized that four (4) directors were in attendance, so there was a quorum for the meeting. The meeting was called to order at 10:35 a.m., and Scott Riley gave a brief overview of the purpose of the meeting.

- 1. The first item of business was to approve the meeting minutes from the board meeting held on 11/8/21. Director Carril made a motion to approve such minutes that was seconded by Director Maritz. The board then unanimously voted to approve such minutes.
- 2. The board then moved on to address and discuss Resolution No. 2022-01, which provided for the election of the officers of the District as follows:

Director Carril made a motion to approve Resolution No. 2022-01 that was seconded by Director Ramos. The board then unanimously voted to approve Resolution No. 2022-01.

3. The Board then considered and discussed Resolution 2022-02, which provided for the appointment of an Executive Director of the District and for the appointment of an Assistant Executive Director for the District. This resolution further outlined some of the powers delegated by the board to the Executive Director and the Assistant Executive Director. The resolution appoints Mark Winkeler as the Executive Director and appoints Chris Carril as the Assistant Executive Director. Director Carril made a motion to approve Resolution No. 2022-02 that was seconded by Director Ramos. The board then unanimously voted to approve Resolution No. 2022-02.

- 4. The board then moved on to Resolution 2022-03. Scott Riley and Director Winkeler both commented on the budget process and explained that this resolution was related to the approval of the District's budget for the upcoming fiscal year 1/1/2023 12/31/2023 as required by Missouri law. Director Carril made a motion to approve Resolution 2022-03 that was seconded by Director Maritz. The board then unanimously voted to approve Resolution No. 2022-03.
- 5. The board then moved on to Resolution 2022-04. This resolution sets forth the procedure and documentation to be used by all Maritz-related entities to submit CID project costs for approval and reimbursement from the District. Scott Riley confirmed that Cook & Riley, LLC has reviewed and approved all expenses included in disbursement request number 2022-01, which was presented to the District to evidence security service expenses incurred within the District, as being allowed pursuant to the CID Act and noted that an opinion from Cook & Riley, LLC was also attached to Resolution 2022-04 for the board's benefit. Director Maritz made a motion to approve Resolution 2022-04 that was seconded by Director Carril. The board then unanimously voted to approve Resolution No. 2022-04.
- 6. The board then moved on to Resolution 2022-05. This resolution sets forth the slate of individuals being nominated to serve as successor directors of the District. Director Maritz suggested that all the current board members be nominated to serve as successor directors. Director Carril made a motion to approve Resolution No. 2022-05 that was seconded by Director Maritz. The board then unanimously voted to approve Resolution No. 2022-05.

There being no further business to come before the board, Director Carril made a motion that the meeting be adjourned, Director Maritz seconded this motion, and it was unanimously passed by the board. The meeting was adjourned at approximately 10:50 a.m.
