BUDGET MESSAGE

The La Collina Community Improvement District (the "District") was formed as a not for profit corporation of the State of Missouri on November 16, 2018, by the City of St. Louis, Missouri by the approval of a Petition for the Establishment of a Community Improvement District (the "Petition") by Ordinance No. 70859, as amended by Ordinance No. 70928. The District was formed for the purpose of providing revenue sources to fund the costs of certain improvements that serve the area encompassing the District.

The District's primary source of revenue is a special assessment, the collection of which commenced in 2019 and will terminate in 2028. The entirety of the District's special assessment revenues may be used for any purposes specified in the Petition.

No major changes are expected for the District during fiscal year 2023-2024.

The District has adopted a fiscal year beginning July 1 and ending June 30 of each year.
