#### I. CALL TO ORDER

Pursuant to the Notice and Proposed Agenda of the meeting, there was a conference call line established to facilitate the participation of the board members and any interested members of the public.

#### II. ROLL CALL

#### III. NEW BUSINESS

Before considering the resolutions on the Agenda, Scott Riley stated that this Special meeting was necessary to authorize the resolutions related to the holding of an election to select successor members of the Board of Directors. Scott Riley stated that the resolutions were circulated to the Board prior to the meeting and then reviewed each resolution in detail, including a discussion about the legal fees being authorized in Resolution No. 2023-03. The resolutions were as follows:

Resolution No. 2023-0I - Authorizing a Mail-In Election to Select Successor Directors and Notifying the City Clerk of the City of Northwoods, MO of the Need for an Election, to Set Dates for an Election and Set Dates for Declarations of Candidacy

Resolution No. 2023-02 - Authorizing a Mail-In Election to Select Successor Directors and Notifying the St. Louis County Election Authority of the Need for an Election

Resolution No. 2023-03 - Authorizing a Written Request for Disbursement from the Operating Fund of the North Oaks Plaza Shopping Center CID Sales Tax Revenue Bonds, Series 2008 to pay legal fees in the amount of \$15,000 to Cook & Riley, LLC for election-related legal work

Scott Riley asked if any of the board members had questions about the resolutions. As there were no questions, Director Sansone made a motion to adopt Resolution No. 2023-0 I, Resolution No. 2023-02 and Resolution No. 2023-03. Director McGowan seconded the motion. A vote was held and the directors unanimously approved Resolution No. 2023-0 I, Resolution No. 2023-02 and Resolution No. 2023-03.

After the vote, Scott Riley observed that this was likely the last meeting in which the current directors would participate, and he stated that all directors would need to submit letters of resignation, which will be drafted and sent to the current directors by Cook & Riley, LLC.

There being no other business to come before the meeting, Director Sansone made a motion to adjourn the meeting. The motion was seconded by Director McGowan. A vote was held, and the motion unanimously carried and the meeting was adjourned at approximately 9:15a.m.

#### SECTION NO. 2

The District will request that the date for this mail-in election should be set on a future date as determined through discussions between the District's officers or Cook & Riley, LLC, as special counsel for the District, with the St. Louis County Election Authority and the City Clerk of Northwoods, Missouri. When chosen, such election date will be the basis of creating an election-related "Schedule of Events" timetable consistent with the requirements of the CID Act and Chapter 115, RSMo. The officers of the District, with the advice of Cook & Riley, LLC as special counsel, shall prepare this "Schedule of Events" and, when completed, it will be incorporated herein as Exhibit A.

#### SECTION NO. 3

Candidates for the office of director must file their declarations of candidacy with the City Clerk of Northwoods, Missouri during normal business hours as specified in  $\underline{Exhibit\ A}$ . As part of the approval of Resolution No. 2023-01 and this SECTION NO. 3, the Board of Directors recognizes that the filing deadline for candidates to file their declarations of candidacy with the City Clerk of Northwoods, Missouri is determined by reference to section 67.1451.4 of the CID Act and section 115.127.5, RSMo, and the effective date of this Resolution No. 2023-01. Accordingly, the Board of Directors is authorizing Cook & Riley, LLC, as special counsel for the District, to set the effective date of this Resolution No. 2023-0 I when setting the election date and preparing  $\underline{Exhibit\ A}$  to insure that all necessary, election-related actions are consistent with the requirements of the CID Act and Chapter I 15, RS Mo.

#### SECTION NO. 4

This resolution authorizes the officers and agents of the District to expend monies on the publication of notices for the election itself and for the declaration period for candidates to fill the board positions as required by the Act and related/incorporated Missouri statutes.

#### SECTION NO. 5

This resolution also authorizes Cook & Riley LLC to act as special counsel for the District, and in such capacity authorizes Cook & Riley, LLC to interact with the St. Louis County Election Authority, the County Counselor's office the office of the City Clerk of Northwoods, Missouri, the City of Northwoods, Missouri City Attorney and any other governmental officials, as needed or expedient, in order to effectuate this mail-in election.
