In response to your request for clarification of the Bowling Green License Office Evaluation Summary for RFPDORS20064 posted on May 3, 2023:

First, DOR assumes this correspondence is not meant to be accepted as a formal protest against the award and will respond accordingly.

DOR acknowledges a mistake was made and 2015 Schotthill Woods LLC should have received an additional 8 points for its selection on Section B-6B, resulting in a final score of 180.50 instead of 172.50 for 2015 Schotthill Woods LLC's proposal for the Bowling Green License Office. However, since this was a single bid office and the final award is not affected by a change of scoring, no further action will be taken.

A copy of this correspondence will be added to DOR's RFPDORS20064 files to document the error.

We do need clarification as to why no points were awarded for no missing inventory in the previous two years. The Vendor 2015 Schotthill Woods LLC has not had any missing inventory in the previous two years and has managed a license office contract since December 2021. It states DOR verified \$0.00 in missing inventory. I wanted to confirm if this was an oversight or mistake.

Dandelion Fields LLC was recently awarded the Crane location. They did receive the full 8 points under this section and have also only been managing a license office contract since December 2022.

Prior to acceptance on our end, we would request why OA/DOR did not allow for points in this section.
